

ON LICENCE

PURSUANT to the Sale and Supply of Alcohol Act 2012 **The Simply Food Catering Company Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **29 Hutt Road, Wellington**, and known as **Simply Food**, to any person for consumption on the premises and to let people consume alcohol there.

Section 38 of the Act applies to this licence **The Simply Food Catering Company Limited** is authorised to deliver alcohol from the premises and sell it on any other premises for consumption on those other premises by people attending a reception, function, or other social gathering promoted by a person or association of people other than the licensee.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption under this licence on the following days and hours: **Monday to Sunday 10.00am to 1.30am the following day;**
2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
4. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted.
6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.
7. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.

The following condition applies at the premises situated at 29 Hutt Road, Thorndon, Wellington:

8. The Licensee must display:
 - a. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for the sale or supply of alcohol;
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

The following condition applies at any other premises at which the licensee sells or supplies alcohol pursuant to this licence:

9. The Licensee must display at every point of sale or supply at such premises, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

The premises are as set out on the plan submitted with the application and date stamped 15 June 2017.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the renewal, suspension and cancellation of licences, this licence expires on:

12 July 2020
